From the Pastor's Pen

Dear friends,

Grace and peace to you, as our walk through Lent soon comes to a close. We are nearing the holiest week of the church year – a time when our journey to the cross becomes even more deliberate and intense. It is during Holy Week that Jesus plainly and fully reveals to us who God is – God is indescribable, unbounded love ... recklessly pursuing us, wherever we might be. He shows us what this love looks like by humbling himself, sharing a meal with and washing the feet of his friends, who would soon abandon and betray him, and then, giving himself up and freely going to the cross. In the turmoil and struggle of that week, Jesus calls us to love others in the same way. I invite and encourage you all to join your Trinity family, as we experience Holy Week together.

On Maundy Thursday, we will sit at the table with Jesus and his disciples. We will hear his words of love for them, watch him get down on his knee and clean the filth from their feet, and we will consider his command to love one another as he has loved us. As we celebrate the Eucharist together, we will honor those in our midst who will be receiving Communion for the first time. We will close our time of worship together by stripping the altar and pondering the mystery of God's sacrificial love.

Good Friday will offer us a couple different opportunities to hear and reflect upon Christ's passion story. We will begin with a traditional Tenebrae service, in which we will methodically move from light into darkness alongside the Gospel of John's telling of Jesus' final hours. This service is always a powerful and moving experience. Then, later in the evening, we will have the dramatic Watch the Lamb service, after several years off. For many, this beautiful service has been a highlight of their Holy Week.

Then, on Easter Sunday, we will have several opportunities to celebrate the resurrection of our Lord, beginning with the sunrise service. Our Trinity youth will help plan and lead this service, and they're sure to put a creative spin on this worship experience. The sunrise service will be followed by our traditional brunch, served in the fellowship hall. For all of the non-early-birds, we will also have Easter worship at both of our normal Sunday worship times, as well.

I hope you will take advantage of all the opportunities we have to gather and worship together, as a faith community, during Holy Week. It is such a significant time for reflection and formation. The power and potential of the resurrection is really contained in the days that lead up to Easter. Blessings to you all in these final days of Lent.

Pastor Steve summarized his written report and said that the attendance at the January 7 Saturday service was very good.

In addition, a notice indicating that this information may found in the newsletter will be printed in the bulletin. Motion carried.

Trinity's constitution needs revision. Vice-president Tom Farrell, Pastor Steve Lindley, Dan Brown, and Jim Iverson have volunteered to serve on a Constitution Committee. The committee is charged with

- 1. Examining the existing governance structure
- 2. Determining when last ratified by the congregation
- 3. Bringing into compliance with synod guidelines
- 4. Bringing the document to the council
- 5. Special congregational meeting to ratify

Motion by Tom Farrell, seconded by Jennifer Briggs, to appoint the members and approve the charges to the committee. Motion carried.

Pastor Steve, Dana Hoff, Jennifer Briggs, and Scotty met with a representative from Specialized Floor Coverings regarding new flooring for the kitchen. Two bids were submitted—one for the kitchen alone (\$7,339.13) and one including the kitchen and the serving area just outside the kitchen (\$16,584.02). Trinity has received a donation to cover the amount for the kitchen floor. Motion by Becky Brown, seconded by Virginia Lemme, to proceed with the entire project, kitchen and serving area, the total expense not to exceed \$19,000. Motion carried.

Welcome to Trinity item was tabled.

Vice-president Tom Farrell addressed the investment of money from the parsonage fund loan. His proposal is to purchase one 12-month CD in the amount of \$5,000 and one 15-month CD in the amount of \$10,000 at 1st Bank & Trust. The balance of the money in the I Am In campaign fund will be invested later layering maturation dates. Motion by Tom Farrell to proceed with the purchase. Seconded by Becky Brown. Motion carried.

The Council approved the removal of the COVID Precautions signs.

President Wade Briggs announced the schedule for board and council meetings.

Pastor Steve closed the meeting with prayer.
